The LGIA We Are What We Are. And We Aren't What We Aren't.

The Lake Gogebic Improvement Association isn't, can't, and doesn't pretend to be all things to all people. It's not in our power, for example, to control the water level (the Federal Energy Regulatory Commission and the Upper Peninsula Power Company do that). Nor are we a property owners association or agency of government that pre- or proscribes what you can or cannot do. Nor are we empowered to negotiate or control the number of fish allotted each year for our Native American friends (that is a matter of sacred Treaty rights). The LGIA is simply a voluntary, low-budget, non-profit organization of dues-paying members with a Board of Directors who care--and care a lot--about Lake Gogebic.

Search for "**Protecting Lake Gogebic**" on **Facebook**. You'll discover one of the primary interests of the LGIA: clean boats and clean waters go hand in hand. If you've seen the boat washer and volunteers at boat landings around the Lake, that's the LGIA.

Inland waters in the Upper Midwest are increasingly vulnerable to **aquatic invasive species**. Lake Gogebic is no exception. Everyone on the Lake has a vested interest in AIS. Understanding the potential of the problem, monitoring the Lake, and eradicating threatening aquatic life is a top priority for the LGIA.

Historically, the Lake Gogebic **fishery** has been a source of pride. At the request of property owners, the LGIA has placed dozens of **fish cribs** in the Lake to help maintain the fish population. Perhaps you or your neighbors have one. And each year more are built and placed.

The LGIA is also working to build a **website**. **LakeGogebicIA.com**. It'll be a place where you can track with the work of the Association and all things Lake Gogebic, with links to interesting and relevant resources. And you may have a photo to share or a story to tell about life on Lake Gogebic that can be posted on the site.

Lake Gogebic has always been and is a clean and clear body of water. To ensure that this remains, the LGIA participates in Michigan's **Cooperative Lakes Monitoring Program**, documenting indicators of water quality.

Because highway litter is a near relative of polluted water, the LGIA participates in Michigan's **Adopt-A-Highway** program.

The LGIA also has a social side. Each July (except 2020 and 2021), in conjunction with it's **Annual Meeting**, the LGIA hosts a **picnic** at the Gogebic County Park. In October, a **Fall Gathering** dinner wraps up the boating season.

Participating and contributing members are the lifeblood of every community of people. The Lake Gogebic Improvement Association is no different.
